To ensure responsiveness to the RFQ Bidders to take note of the following requirements (Compliance Evaluation):

1. Service providers must be registered on National Treasury's Central Supplier Database and submit a summary report as proof of registration or alternatively reflect the CSD supplier number on their proposal;
2. All prospective/interested suppliers should complete the MBD 4, MBD 8 and MBD 9 forms which may be obtained from the BCMDA website: www.bcmda.org.za;
3. All prices must be inclusive of VAT, where applicable;
4. Use of Tippex and erasable ink will render the bid non-responsive;
5. Bidders are required to submit valid B-BBEE Status Level Verification Certificates together with their bids, to substantiate their B-BBEE rating claims, failing which will result in a status level score of zero be assigned to the tenderer; a joint venture, trust or consortium; must submit a consolidated B-BBEE status level verification certificate.
6. Bidders must submit confirmation that the bidder's municipal accounts are not in arrears for a period exceeding 3 months. Such confirmation must be for the company must be as follows:

PURPOSE

Buffalo City Metropolitan Development Agency (BCMDA hereby invites proposals for the supply of an Digital Signature (e-Signature) solution. The purpose of this document is to unpack the requirements applicable to the e-Signature solution.

SCOPE OF THE SERVICE REQUIRED

The Digital Signature solution should provide the following:

Buffalo City Metropolitan Development Agency (BCMDA Requirements

- Solution should be able to provide digital signature capability for the documents as a stand-alone.
- The solution should provide functionality to sign documents digitally and easily send documents for digital signature. This includes the ability to provide real-time visibility into the status of a document.
- It should provide the ability for real-time visibility of the status the document sign-off request is in.
- The solution must be able to add signature blocks to all documents formats and automatically convert to PDF for signature.
- The solution should provide sufficient security and advanced authentication methods (2 factor authentication) to validate the signatory's identity and the data should be securely encrypted.
- An audit trail of the document workflow information should be retained for proof of compliance, from initiation to completion.
- The resulting digital signatures should be legally enforceable (digital signature evidence should be admissible in a court of law).
- The solution should also work on mobile devices e.g. smartphone (Android and iOS). This will enable users to review and sign documents using mobile devices.
- It should have basic fields i.e. (Collect name, date, signature, initial, company name and tittle.)
- It should have reminders and Notification i.e (Set up automatic email reminders and deadline notification for your receipts)
- Personalised branding i.e. (Reflect your brand on the notification emails seen by receipt. Add custom logo specify colour themes and more.)
- Reusable templates

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
